<sup>2</sup> You may want to use the local name for the LSC instead of, or in addition to, mentioning NSF, perhaps even giving examples of specific activities.

<sup>3</sup> Only teachers that the project indicated have participated in 20 or more hours of professional development have been included in the random sample for teacher interviews. If a teacher indicates he/she has not participated in 20 hours of more hours of LSC professional development, a teacher from the backup sample should be interviewed instead for the core evaluation.
